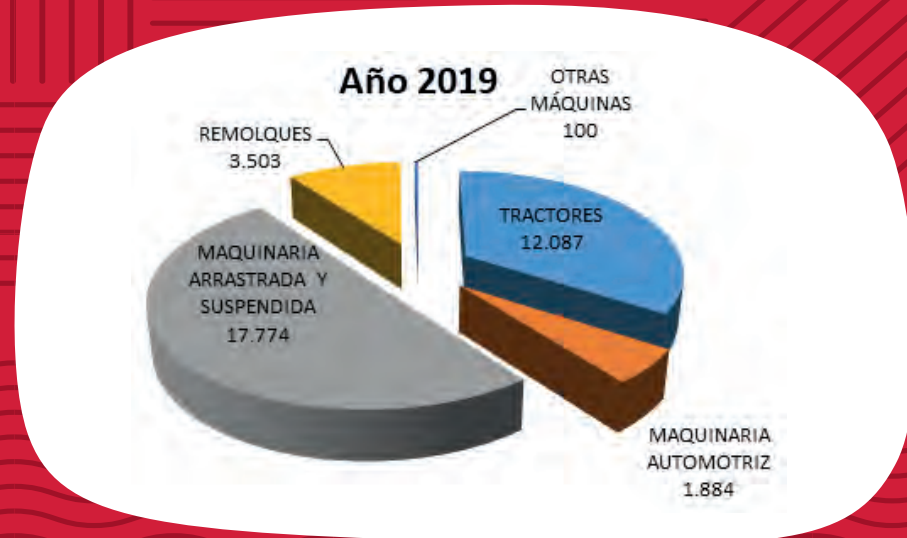
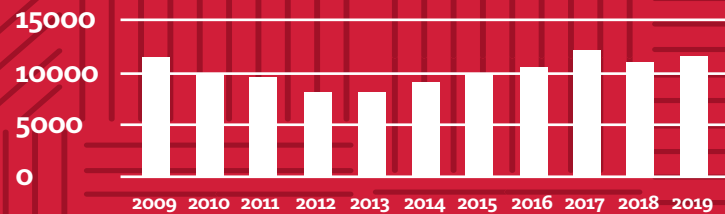

ACTIONS MAPA AND THE SECTOR OF THE AGRICULTURAL MACHINERY

Registration in the ROME, regulated by RD 1013/2009, of June 19, on characterization and registration of agricultural machinery, is mandatory for:

- Agricultural and forestry tractors of any type and category.
- Cultivators and tractor units.
- Automotive machines of any type, power and weight.
- Trailed machines of more than 750 kg of maximum mass with permissible load of the vehicle in circulation.
- Agricultural trailers.
- Deposit for the transport and distribution of liquids.
- Equipment of phytosanitary treatments dragged or suspended.
- Trailed or suspended fertilizer distribution equipment.
- Agricultural machines not included in some of the previous sections, for whose purchase a credit or an official subsidy has been granted.

RENOVE Plan: Subsidy for the acquisition and scrapping of certain agricultural machines (RD704 / 2017). With the RENOVE 2019 Plan, 5 million euros have been allocated for the acquisition of 558 machines. More than half of the budget has been allocated to seeders by direct sowing.

Official laboratory of MAPA

The EMA is recognized by the Organization for Economic Cooperation and Development (OECD), as the only official Spanish laboratory for conducting OECD tests on agricultural and forestry tractors and their protection structures. It is also designated by the Ministry of Industry, Commerce and Tourism as a technical service for the approval of agricultural or forestry vehicles.

Diffusion programs and demonstrations of machinery. To publicize the technical innovations that are occurring in the machinery sector, which allow a more rational use of the means of production and that provide greater operator safety and lower pollutant emissions, in order to contribute to the sustainability of the operation agricultural.



TRACTOR POWER TESTS (A power take-off and pull to the bar): for energy efficiency tests and for tests according to OECD Code 2.



TESTS OF PROTECTION STRUCTURES IN CASE OF TIPPING (ROPS) AND FALL OF OBJECTS (FOPS): in accordance with Regulation (EU) n°167 / 2013, according to codes 4, 6, 7 and 8 OECD or trials for reforms by the RD 866/2010.



Equipment for the application of phytosanitary products: MAPA coordinates the actions of RD 1702/2011, of November 18TH, of periodic inspections of equipment for the application of phytosanitary products. Since 2020 the teams have to pass the inspection every 3 years to ensure proper application.
